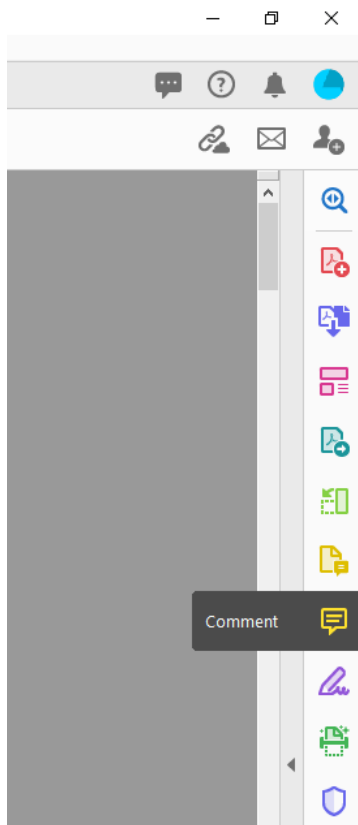

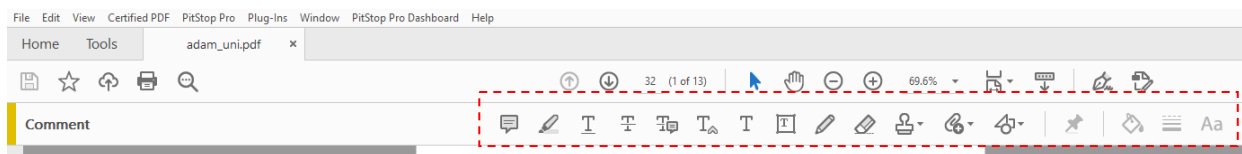

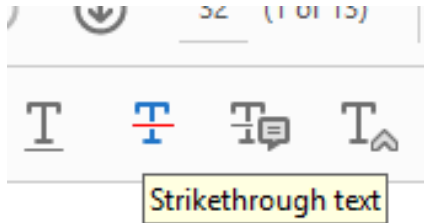


You will now see a Comment tool bar (as below)

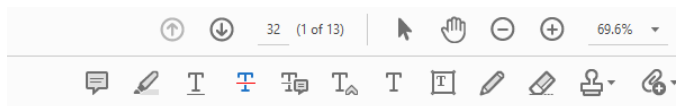




If you wanted to show that you were deleting text - click on the strikethrough option (as below)

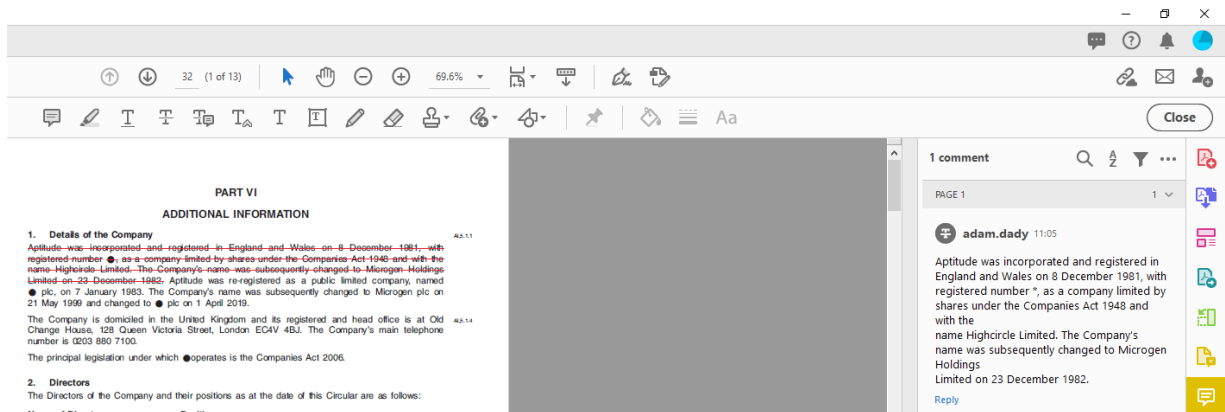
**1. Details of the Company**

The Company's name was subsequently changed to Microgen Holdings Limited on 23 December 1982. Aptitude was re-registered as a public limited company, named ● plc, on 7 January 1983. The Company's name was subsequently changed to Microgen plc on 21 May 1999 and changed to ● plc on 1 April 2019.

The Company is domiciled in the United Kingdom and its registered and head office is at Old Change House, 128 Queen Victoria Street, London EC4V 4BJ. The Company's main telephone number is 0203 880 7100.

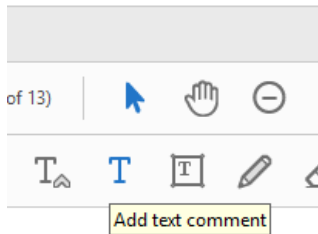
